- K. Purchase from rail yard of containers to be used in place of tin horns was discussed. Rail yard containers available for sale, 10' diameter, 57' long, usually sell for \$420.00/ linearft, 8 available. 8' diameter tin horn sells for about \$8000.00 but are lighter weight and often do not survive severe flooding. These containers are much heavier and would be unlikely to be displaced by flooding. Honeycutt to follow up on pricing and hauling. Board agreed to a container price range between \$11,000.00 and \$15,000.00. Motion to defer pending additional information to be gathered by Honeycutt, 2nd by Anderson. EM Director Hedges stated that she was just notified by FEMA that they would have a team in Cotton County on June 3, 2025 to assess flood/storm damage for their report for possible FEMA Disaster declaration. There has been a preliminary estimated \$20 million of damage in a tri-county area that includes Cotton, Comanche and Stephens counties. Sheriff Tim King reported that there was a two-car collision of Sheriff Department vehicles responding to a call over the holiday weekend is currently under OSBI investigation according to procedure. Sheriff King expects a report within a couple ofweeks.
