### NOTICE OF SALE OF REAL ESTATE FOR DELINQUENT TAXES LOCATED IN COT- TON COUNTY, STATE OF OKLAHOMA

Notice is hereby given that, under authority and direction of 68 O.S. § 3101 et seq., the hereafter described lands, lots tracts and parcels of real estate, all situated in Cotton County, Oklahoma, now has a tax lien for unpaid ad valorem taxes and/or special assessments. Further, if the lien remains unpaid for a period of three years or more, as of the date such taxes first became due and payable, this property will be sold at public auction interest the delinquent taxes, unless and penalty are paid in full prior to the time of the tax sale.
